Presentation of the MS4 Annual Report by Sam Carroll.

- Locally we have an impaired waterway, meaning it is polluted by DEP standards.
- We are currently waiting on design permits to move forward.
- Goals are to remove sediments and create broad flood plains.
- This project is set to be completed by March 15th, 2023.
- Maryann Weinstein requested an update twice a month on this project beginning October 3rd.

Council reviewed the status of the park/playground project. Bioni is hoping to be finished by the end of the month.

Motion Doug Corwin, seconded by Joseph Fulton to approve Ordinance #549 - Delinquent tax collection by Portnoff. Motion passed unanimously.
